## E. Anthony Rankin, MD Receives Diversity Award

During the AAOS Annual Meeting Dr. E. Anthony Rankin, EOA Past President and Managing Director, was presented with the Diversity Award in recognition of more than 40 years of educating and inspiring generations of minority and female orthopaedists and providing high-quality, culturally competent care to untold numbers of patients in the United States and around the world.

When Dr. Rankin, MD, arrived at his first AAOS Annual Meeting in 1967, he found only two African-American orthopaedists in attendance. Back then, there were only about 10 board-certified African-American orthopaedic surgeons practicing in the United States. Spurred on by this lack of diversity, Dr. Rankin—who became the Academy's first African-American president in 2008 — chose

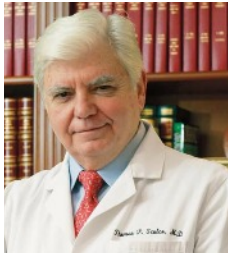

## Presidential Guest Speaker

Thomas P. Sculco, MD



EOA is pleased to announce that Dr. Thomas P. Sculco, MD is the 2016 Presidential Guest Speaker. Dr. Sculco is currently Surgeon-in-Chief Emeritus of Hospital for Special Surgery and Professor of Orthopaedic Surgery at Weill Cornell Medical College.

Dr. Sculco's research interests are currently centered on improvements in surgical technique and preventing failure of hip and knee implants. He has been awarded both the Otto Aufranc and the Charnley Award from the Hip Society for his work with Thrombogenesis in Total Hip Replacement. He has received the Arthritis Foundation's Lifetime Achievement Award. He is the first American to be elected as an Honorary Member of the Austrian Orthopaedic Society and has also been named an Honorary Member of the Hellenic Orthopaedic Society. Dr. Sculco was awarded the Humes Professorship in Salzburg, Austria. In

2005 he received the Gold Medal Award for Clinical Medicine from Columbia University College of Physicians and Surgeons and in 2013 he was awarded the Austrian Cross of Honor, First Class, for Science and Art.

He has written over 350 papers, 75 chapters, three books on orthopedic surgery and the surgical treatment of arthritis and has presented over 750 papers.

Dr. Sculco founded the International Society of Orthopaedic Centers and served as Executive Director for 10 years. He also founded the VA Orthopaedic Society and was a founding member of the Knee Society and is its President in 2016. He is a member of the Board of Directors and was Treasurer. Dr. Sculco served on the Board of Directors of the American Academy of Orthopedic Surgeons, and the Arthritis Foundation. He presently serves on the Board of Directors of Carnegie Hall. Dr. Sculco was the honoree at the Columbus Day Parade in 2011. He is a Board Member of OREF and the Robert Gladden Society.

## Howard Steel Lecturer

James Carville



EOA is pleased to welcome James Carville as the 2016 Howard Steel Lecturer. James "The Ragin' Cajun" Carville is America's best-known political consultant. His long list of electoral successes evidences a knack for steering overlooked campaigns to unexpected landslide victories and for re-making political underdogs into upset winners.

His winning streak began in 1986, when he managed the gubernatorial victory of Robert Casey in Pennsylvania. In 1987, Carville helped guide Wallace Wilkinson to the governor's seat in Kentucky. Carville continued his winning streak with wins in New Jersey with Frank Lautenberg elected to the US Senate. He next managed the successful 1990 gubernatorial campaign of Georgia's Lieutenant Governor Zell Miller, including a tough primary win over Atlanta mayor Andrew Young, and in 1991, Carville—who had already become prominent in political circles—drew national attention when he led Senator Harris Wofford from 40 points behind in the polls to an upset landslide

victory over former Pennsylvania Governor and U.S. Attorney General Richard Thornburgh. But his most prominent victory was in 1992 when he helped William Jefferson Clinton win the Presidency.

In recent years, Carville has not been a paid political consultant for any domestic politicians or candidates for office, instead focusing on campaigns in more than 20 countries around the globe, including leading Ehud Barak to victory in his campaign to become the Prime Minister of Israel in 1999.

Carville is also a best-selling author, actor, producer, talk-show host, speaker and restaurateur. His titles include *All's Fair: Love, War, and Running for President* (with wife Mary Matalin); *We're Right, They're Wrong: A Handbook for Spirited Progressives*; *And the Horse He Rode In On: The People vs. Kenneth Starr*; *Buck Up, Suck Up... and Come Back When You Foul Up*; *Had Enough? A Handbook for Fighting Back*; *Stickin': The Case for Loyalty*; *40 More Years: How the Democrats will Rule the Next Generation* (2009) and the New York Times best seller, *It's the Middle Class, Stupid!* (2012), co-authored with Stan Greenberg. He also authored a children's book entitled *Lu and the Swamp Ghost*.

In their second joint memoir, *Love and War: Twenty Years, Three Presidents, Two Daughters and One Louisiana Home* (2014), Carville and Matalin take a look at how they—and America—have changed in the last two decades. In their two distinct voices, they pick up their story from the end of the 1992 Presidential campaign to their new life in New Orleans today where their efforts to rebuild and promote that city have become a central part of their lives—and a poignant metaphor for moving the nation forward.

Along with pollster Stanley Greenberg, Carville founded Democracy Corps, an independent, non-profit polling organization dedicated to making government more responsive to the American people. Democracy Corps has conducted over 200 national, congressional and local surveys, interviewing over 220,000 American voters during the past 10 years.

Carville is a Fox News contributor and can also be seen on other networks worldwide. He is a columnist for *The Hill* newspaper which publishes daily when Congress is in session and serves as a Professor of Practice at Tulane University in New Orleans, where he lives with his wife Mary Matalin and their two daughters.

## Bylaws Changes

The following Bylaws changes will be presented to the membership for approval at the 2016 Annual Meeting at The Ritz-Carlton in New Orleans, LA, October 19-22, 2016. The copy in red is recommended additions and copy struck through is to be removed.

### Article IV Membership

#### SECTION 2: Active Membership Qualifications

A. Active Membership in the ASSOCIATION shall be open to qualified orthopaedic surgeons who meet the following criteria.

He/she must:

(1) Be a physician who maintains a full and unrestricted license to practice Medicine, and practices, or at the time of initial membership in the ASSOCIATION, practiced within the geographic boundaries of the ASSOCIATION or outside the United States;

(2) Be a Fellow in good standing of the American Academy of Orthopaedic Surgeons or an equivalent organization as determined in the sole discretion of the ASSOCIATION;

(3) Agree to be bound by and adhere to the Principles of Medical Ethics of the ~~American Medical Association~~ **American Academy of Orthopaedic Surgeons**. Members of the American Osteopathic Association agree to be bound by and adhere to the Code of Ethics of the American Osteopathic Association;

(4) Maintain high professional, moral and ethical standards in his/her community;

(5) Comply with the dues, fees, and assessment requirements as well as these Bylaws and Policy Statements established from time to time by the Board of Directors of the ASSOCIATION.

B. Active Members are eligible to vote, hold office, serve on committees, and sponsor applicants for membership.

~~C. Active Members do pay dues, fees and assessments. Active Members who have twenty (20) years of service and have reached the age of sixty are eligible for reduced membership fees as specified in ARTICLE XVI, SECTION 2B.~~

C. Conformity to these criteria in their entirety continues an Active member in good standing.

D. Requirement number 2 of this Section may be waived, at the discretion of the Board of Directors, for those individuals who joined the ASSOCIATION before these requirements were in effect and who have remained members in good standing since their initiation.
